## ***Introduction***

The domestic debt of Bosnia and Herzegovina consists of direct and indirect domestic state debt, as well as the domestic debt of entities and the Brčko District.

The Ministry of Finance and Treasury of BiH, based on Articles 18 to 22 of the Law on Borrowing, Debt and Guarantees of BiH (*Official Gazette of BiH*, 52/05, 103/09, and 90/16), establishes and maintains records regarding the overall domestic debt, debt of entities and the Brčko District, including the debt of cantons, cities, municipalities, funds, etc, based on data provided by entities and the Brčko District, in accordance with the applicable laws of entities and the Brčko District.<sup>1</sup>

The Ministry of Finance and Treasury of BiH prepares quarterly reports on domestic debt, which present the status and structure of domestic debt, as well as the most significant changes that occurred in the observed quarter, based on the information received from the Ministry of Finance of the Federation of BiH, the Ministry of Finance of Republika Srpska, and the Directorate for Finance of the Brčko District.

Currently, there is no direct and indirect domestic state debt, and the domestic debt of Bosnia and Herzegovina consists of the domestic debt of entities and the Brčko District, the domestic debt of cantons, cities, and municipalities, the debt of funds, domestic debt of public enterprises, as well as the domestic debt of public enterprises registered in the Registry of Legal Entities established by the Institutions of BiH, which is maintained by the Ministry of Justice of BiH.<sup>2</sup>

The domestic debt of BiH as of September, 30, 2024. amounts **4,112.34 mil BAM<sup>3</sup>** and it is lower by 77.74 mil BAM or 1.86 % compared to the state as of June, 30 2024.

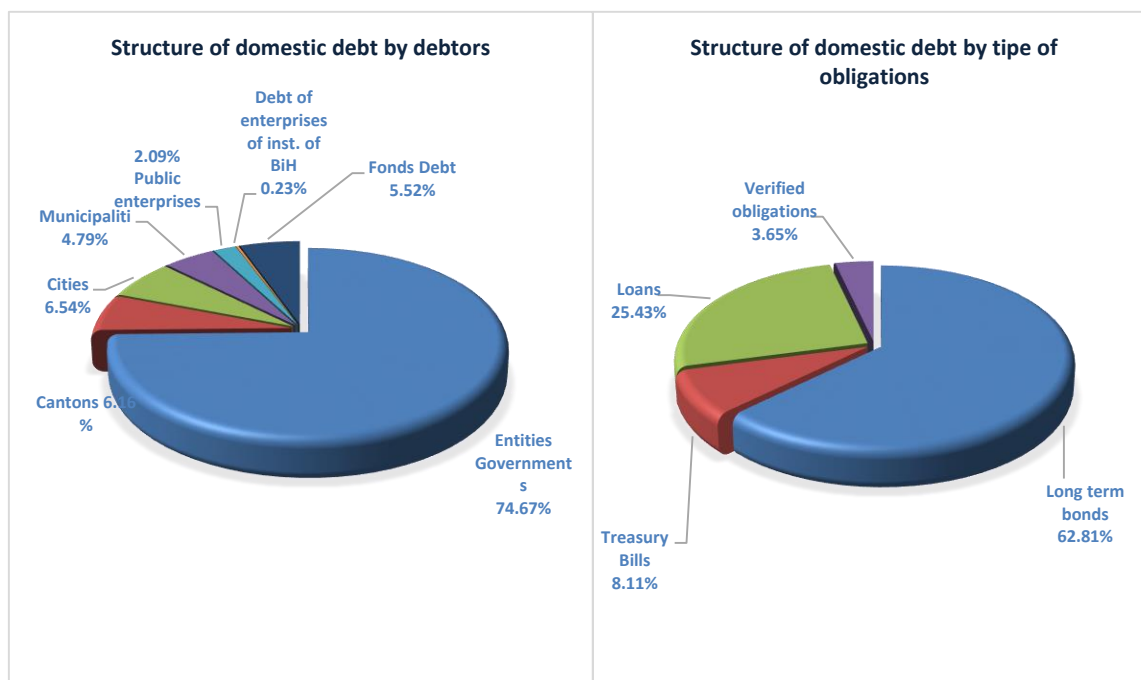

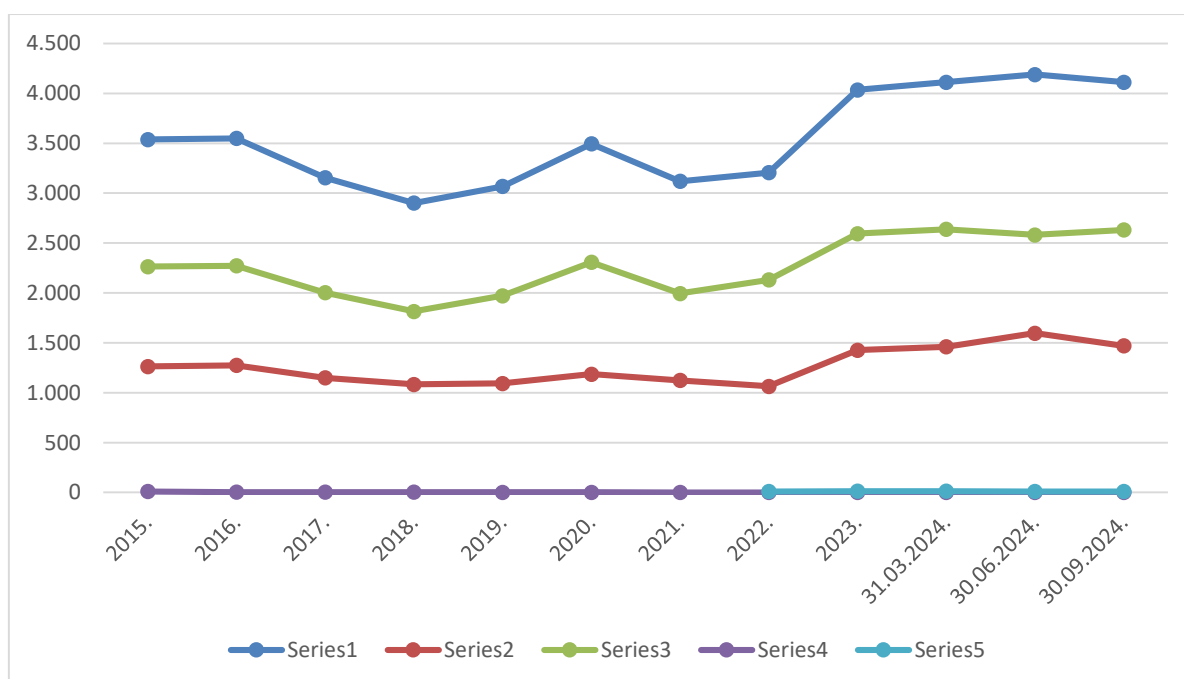

In the third quarter of 2024 the FBiH Government issued long-term bonds in one occasion in the amount of 30.00 mill BAM, with interest rate of 4.65% and maturities of 10 years. In the same period, the FBiH Government paid 43.64 mill BAM, with 40.00 mill BAM maturities, and 3.64 mill BAM of interests.

In the third quarter 2024 Government of RS issued long-term bonds in three occasion in the amount of 30.00 mill BAM, with maturities of 5 years and the interest rate of 6.00%.

In this quarter, the Government of the Republic of Srpska paid 80.40 mill BAM on long-term bond liabilities, 57.26 mill BAM on principal and 23.17 mill BAM on interest.

In this period, the Government of RS issued the eleventh series of bonds of the RS for the settlement of liabilities based on *old foreign currency savings accounts* (for savers who verified *old foreign currency savings accounts* in the period from 1, February 2023 to 29, February 2024) in the amount of 6.78 mill BAM, with an interest rate of 2.5% and a maturity of 5 years.

In the third quarter 2024 FbiH Government issued two treasury bills issue in the amount of 50.00 mill BAM. Maturity period 6 and 12 months, with interest rates from 3.02% to 3.32%.

In this period, the Government of the Federation of BiH paid out 97.90 million KM on this basis.

In the third quarter of 2024, the Government of the RS issued treasury bills in three occasions in the amount of 64.43 mill BAM. The maturity is six months, with an interest rate of 4.00%. In the observed period, the Government of the RS paid out 51.40 mill BAM on this basis.
