Introduction

The domestic debt of Bosnia and Herzegovina consists of direct and indirect domestic state debt, as well as the domestic debt of entities and the Brčko District.

The Ministry of Finance and Treasury of BiH, based on Articles 18 to 22 of the Law on Borrowing, Debt and Guarantees of BiH (*Official Gazette of BiH*, 52/05, 103/09, and 90/16), establishes and maintains records regarding the overall domestic debt, debt of entities and the Brčko District, including the debt of cantons, cities, municipalities, funds, etc, based on data provided by entities and the Brčko District, in accordance with the applicable laws of entities and the Brčko District.¹

The Ministry of Finance and Treasury of BiH prepares quarterly reports on domestic debt, which present the status and structure of domestic debt, as well as the most significant changes that occurred in the observed quarter, based on the information received from the Ministry of Finance of the Federation of BiH, the Ministry of Finance of Republika Srpska, and the Directorate for Finance of the Brčko District.

Currently, there is no direct and indirect domestic state debt, and the domestic debt of Bosnia and Herzegovina consists of the domestic debt of entities and the Brčko District, the domestic debt of cantons, cities, and municipalities, the debt of funds, domestic debt of public enterprises, as well as the domestic debt of public enterprises registered in the Registry of Legal Entities established by the Institutions of BiH, which is maintained by the Ministry of Justice of BiH.²

State of domestic debt of 12, December 2024. godine

The domestic debt BiH as of 31, December 2024. amounts **4.504,08 mil BAM** and it is higher by 391.74 mil BAM or 9.53 % compared to the state as of 30, September 2024.



In the total amount of domestic indebtedness as of 31, December 2024, the Federation BiH accounts 40.37%, Republika Srpska 59.43%, and Public Enterprises Etabliher by Institutions of BiH account 0.20%.

In the fourth quarter of 2024, the FBiH Government issued long-term bonds in eight occasions in the amount of 393.00 mill BAM, with interest rate of 3.25 % and 4.65% and maturities of three and ten years.

In the same period, the FBiH Government paid 37.48 mill BAM: 30.00 million KM of principal and 7.48 million KM of interest.

In the fourth quarter of 2024, Government of Republika Srpske issued long-term bonds in two occasions in the amount of 121.00 mill BAM, with maturities of 5 years and interest rate of 6.00%.

The Government of Republika Srpska paid 39.79 million BAM of long-term bond obligations, 28.82 mill BAM of principal and 9.96 mill BAM of interest in this quarter.

In the observed period, the Government of the Republika Srpska issued the eighteenth issue of bonds of the Republika Srpska for the settlement of liabilities based on material and non-material damage incurred during the war period from May 20,1992 to June 19, 1996 in the amount of 632,871 BAM with a maturity of 13 years and grace period of 3 years, with an interest rate of 1.5%.

In the fourth quarter 2024 RS Government issued treasury bills in one occasion in an amount of 21.56 mill BAM, with maturities of six month and interest rate of 4.00%.

In the same period, the RS Governmet paid 67.94 mill BAM on this basis.
