FACTSHEET OF THE EU-FUNDED PROJECT: "DEVELOPMENT OF CENTRAL BODIES OF GOVERNMENTS/COM IN BIH"

BACKGROUND

This project represents continuation of reform initiatives related to the process of development of central bodies of governments that lasts since 2008, when all four governments / CoM adopted the document "Blueprint of development of central bodies of governments / CoM in BiH" (based on SIGMA model of the Center of Governance, CoG and aligned with the the objectives of the Public Administration Reform Strategy in BiH). The "Blueprint" enviseges development of coordination capacities of central bodies regarding 6 specific areas:

- Priority setting, Planning, Policy making / legal drafting, Monitoring, Communications, and selected cross-cutting policies (Public administration reform, EU integration, etc.)

EU DECEB does not cover all coordination functions from the Blueprint but only two:

- Annual planning, monitoring and reporting
- Policy making, legal drafting, and impact assessment.

However, the project was asked to address the issue of medium-term (and to some extent long-term) planning, as well, which derived from the methodological work on annual planning. With regard to the second coordination function, the project is closely related to intiatives on improving quality of legislation and regulatory reform.

The first activity of EU DECEB was to update and upgrade the Gap Assessment produced by the previous project (Blueprint – phase 1, funded by PARCO FUND and finished in 2012). The EU DECEB report on Gap Assessment was based on a slightly different interpretation of the "Blueprint". Firstly, while structures and formal functions are important, actual practices, relationships, methods, and mechanisms for coordination are equally, if not more, important. Secondly, General Secretariat is indeed the "most central" of all central bodies of government, but there is a number of other bodies that either a) are also central bodies, or b) perform the role of a central body though formally are not central bodies (e.g. ministry of finance with regard to budgetary aspects of policy/plan). Hence, this new Gap Assessment – as well as all further EU DECEB work involved, beside General Secretariats, the following:

- Ministries of finance
- Ministries of justice (in RS, the Ministry of administration and local self-government)
- Secretariats/Offices for Legislation
- Bodies involved in central coordination of planning (the Directorate for Economic Planning at the State level and the Federal Bureau for Programming Development)
- Bodies involved in coordination of regulatory impact assessment (the Ministry for Economic Relations in RS)
- Parliaments (with regard to their current role in planning legislation and current / future role in monitoring of implementation / impact assessment)

- Methodology for policy making and impact assessment drafted; consultative meetings/workshops with beneficiaries organised; methodology adopted; tools and templates, manuals and guidance documents prepared; on-the job support for their implementation provided.
- TNA prepared; training plans and programs developed; No of Staff in the Secretariats and in the Ministries trained to implement annual planning and monitoring, and policy development and impact assessment methodologies; evaluation report prepared.
